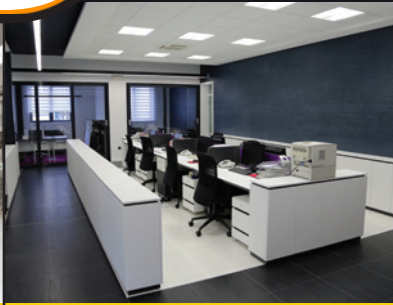

How to get your rebate:

All POS must be system generated documents from the distributor, such as an invoice or summary report by DSR and have the following printed on the document(s): Company Purchased From (Distributor), Company Sold To (End User), Purchase Date (Including the year), and listing of products with Part Number, Description, Size/Case Count, and quantity sold.

- Proof-of-Purchase* must be dated between 03/1/2024 and 6/30/2024 and include all information noted in POS requirements.
